Write on Norfolk has been a real success this year with the finalists being presented at the Forum in early Oct. you may have read some of the entries in the EDP.

The Leader of NCC will be running some roadshows to meet and listen to the public. The dates will be published in the next edition of Your Norfolk.

Proposed development and bypass at Long Stratton

The Clerk reported the meeting with SNC officers to update parish councillors on progress.

The clerk had circulated Norfolk Homes Ltd/Norfolk Land Ltd's Masterplan Strategy document. This had been produced to describe the rationale for the master planning of the bypass and associated development to date (14/08/17): a 'work in progress' explaining the key issues, constraints and assumptions, and how these have led the development team to the current position in progressing application proposals. In addition he had circulated updated documents on 12 September.

Norfolk Homes Ltd/Norfolk Land Ltd's second exhibition will take place on 26 September at SNC and Developer consultation on 2 October at the Methodist Church, Manor Road, Long Stratton. Messrs Hook and Parker and Mrs Allen are to attend and report.

Mr Workman proposed, Mr Turner seconded and it was unanimously agreed to await Mr Webb's checks with SNC/NCC and Mr Delf will report back to the parishioners.

SAM2 Report

Mr Turner reported both SAMs had been erected and he had circulated the reports to councillors. We await a response from Gary Overland at NCC for permission to place the SAM2 unit in some new locations. The Clerk to chase via Mrs Thomas.

Community Speed Watch

Mr Burley had reported the SAM2 information to the police. In addition, he reported there had recently been 1 session per week and several motorists reported. There are now 6 members of the Speedwatch team plus another enquiry. It was agreed as many sessions as possible should be undertaken before the next main parish council meeting, a mix of morning and evening rush hour times with some on B1527. It was established the equipment could be used by any 3 members of the team and Mr Burley did not need to be present.

It was noted the police had been conducting speed checks in the village a few times in the last couple of months.

Mr Hook reported several incidents of speeding and damage to property at the western end of the village on the B1527. Road safety in the village to be on next agenda.

Footpath Maintenance

Mr Rose had contacted Jodie at NCC again regarding dates for cutting but had not received a response. Mr Rose to chase up. Mr Rose to send details to the Clerk who will ask Mrs Thomas to try and progress.

Container / seat area - tidy up / protection of tree

The Clerk had contacted Mr Moulton for a quote for a new and disposal of the old container.

To get a 40' container ex Felixstowe would cost:

- Container, £1175.00
- Delivery, £390.00

Alternatively, Mr Moulton has one in his yard at Eye which is surplus to requirements:

- Container, £975.00
- Delivery, TBA

Mr Delf to investigate the cost of repairs at the appropriate time.

The Clerk had responded to the football club. The football club written back to request:

- 1. the existing left hand container is scrapped and another sound one is sought and placed beside and in line with the right-hand container.
- 2. The bench to be moved.
- 3. The overhanging trees on the west side to be trimmed.

After much discussion, Mr Workman proposed, Mr Delf seconded and it was unanimously agreed that the Clerk should write to the Football Club to:

- Ask how much the Football Club are willing to pay given they are the only users
 of the container.
- State it is not appropriate nor necessary to move the Ray Youngman bench especially as it is used to protect the associated Oak tree.
- Ask them to clear away and dispose of the Football Club rubbish so the grass could be or offer the alternative for the parish council to do this and pass on the cost.
- Once cleared, the parish council will endeavour to move container to suit their needs and assess its condition for repair or renewal.
- Ask for the goal posts to be moved away from the Youngman bench.
- Point out the Oak trees have TPOs and thus permission will be needed to trim them. The Clerk to investigate. It was noted the pitch could easily be moved a few yards to the east to overcome the need to trim.

Since the report the seats in the fort had been vandalised and needed repair. Mr Delf proposed, Mrs Allen seconded and it was unanimously agreed that Mr Medlar to asked for a quote and if within the Clerk's authority the work to be undertaken.

Correspondence from Parishioners

Verge Maintenance

Mr Steve Griffiths wrote to state "The long bank outside my house (Hill House) belongs to the County Council who bought a strip of land from my predecessor in 1971 in order to widen the road. For reasons of safety and visibility both my predecessor and I have maintained about half of it in the absence of maintenance by the Council. The other half, which reaches to the entrance to the footpath across Swan Meadow is now heavily overgrown with trees, bushes and brambles to the extent that the footpath adjacent to it is barely passable. There is one large dead tree next to the Swan Meadow entrance which will soon be a danger. Bits of branches have fallen off it in the weather today.

Several years ago I wrote to the Council [NCC] suggesting that the area be cleared and then maintained. They replied that they would put it on the list for trimming. About a metre width next to the footpath has occasionally been cut (maybe once a year) but the overhang from the trees and bushes now obstructs the pavement.

Since the footpath has been regularly used until now to access this end of the village, including the surgery, I am thinking that this is now a pressing issue.

I know that I could contact the Council directly again but I wonder if doing it with the help of the Parish Council might be more effective. Perhaps you could let me know what you think."

Mr Rose reported that he saw council operatives inspecting the dead ash a couple of weeks ago.

Mr Turner proposed, Mr Workman seconded and it was unanimously agreed that the Clerk should forward Mr Griffiths' letter to NCC highways and state that HPC supports the request made by Mr Griffiths. Mr Griffiths is to be informed of this action.

Financial Statements

Movements since last meeting

The Clerk presented the financial statement attached to these minutes showing the movements from 18 July to 19 September 2017. The statement was not materially out of line with the annual budget. Mrs Allen proposed, Mr Burley seconded and it was unanimously agreed that the statement be approved.

External Audit

The external audit had not resulted in any changes to the figures, however the auditor had commented that the previous year's bank records had been sent in by mistake before the current year one had been sent.

Public Space Protection Orders ("PSPO")

A PSPO is a measure, introduced by the Anti-Social Behaviour, Crime and Policing Act 2014 and introduces wider discretionary powers to deal with any particular nuisance or problem that is detrimental to the local community's quality of life. They seek to ensure that the law-abiding majority can use and enjoy public spaces, safe from anti-social behaviour. The Orders can be enforced by fixed penalty notices or by prosecution.

Chairman's initials _____

SNC are starting a consultation process on a proposal to make a Public Space Protection Order (PSPO) and as part of this process we would welcome parish council input, the consultation and further information can be found here: https://www.south-norfolk.gov.uk/proposed-public-space-protection-order-consultation.

SNC's existing Dog Control Order, which requires the person in control of a dog to clean up after it, will be repealed in October. It is therefore proposed by SNC that a PSPO is introduced requiring a person to clean up after their dog after repeal of the Dog Control Order.

In addition, having regard to residents' concerns, SNC also intend the PSPO to also exclude dogs from enclosed children's play areas (i.e. those enclosed by a fence) in South Norfolk that are open to the air.

Police - South Norfolk Public meeting

Mr Burley will attend the meeting on 28 September and report back.

Mr Hook handed the chair to Mr Delf.

CPRE Norfolk Alliance meeting

Mr Hook attended the meeting on 19 July and reported the meeting was for the 60 parish councils who have signed the CPRE pledge against additional housing site allocations being made in the GNDP area until current allocations have been built.

GNDP

The Clerk had circulated various letters from Shaun Vincent, CPRE and SNC regarding the GNLP and in particular in regard to the potential for issues of predetermination to arise.

Mr Hook reported that legal advice from CPRE National Office explained that the Localism Act 2011, Section 25, Clause 2 enables a Councillor to directly or indirectly express a view that would or might indicate what view he or she subsequently takes on a related matter. Therefore it is entirely appropriate for a Council to support a campaign or formulate a policy which indicates how that council will be pre-disposed in its thinking when a related matter (e.g. site specific allocations in the parish) comes up for discussion.

It was agreed to discuss the matter further upon receipt of the SNC response to the comments made by CPRE.

Mr Hook reported new sites had been put forward for inclusion in the Greater Norwich local Plan and that these were in addition to sites already put forward which are shown on the most recent Call for Sites map.

The additional new sites were all promoted by Will Lusty at Savills for the same landowner and are:

- GNLP1015 1.6ha Land adjacent to primary school 50 dwellings and extension to primary school car park
- GNLP 1016 1.3ha Land at Bussey's Loke 50 dwellings Mrs Allen explained this was the meadow next to the churchyard)
- GNLP 1017 0.9ha Land at Broaden Lane 20-25 dwellings (opposite Old Market Way)
- GNLP 1018 3ha Land south of Millfields 75 dwellings

Mrs Allen left the meeting due to her pecuniary interest.

Mr Workman proposed, Mr Rose seconded and it was unanimously agreed that the Clerk should write to SNC and the GNDP to say that we are aware of the proposed new sites and to reiterate the parish council's policy that development be contained within the existing development boundary and to remind them that we have supported the CPRE Pledge which
