2020/0859 - Mr Adam Austin, 21 Alburgh Road Hempnall - new side and rear extension and new front entrance – Mr Delf proposed, Mr Workman seconded and it was unanimously agreed that the application be rejected on the grounds the plans are so poorly drawn they did not allow sufficient information to be seen to properly judge the application and in addition application document refers to a $2^{\rm nd}$ floor which is not reflected in the drawing so it is unclear what the applicant is proposing.

2020/1428 - Mr William Sargent, Agricultural Building at Fairstead Farm Fairstead Lane Hempnall - Notification for Prior Approval for a proposed change of use and associated building works of an agricultural building to a dwelling house (QA and QB) – Mr Rose proposed, Mr Workman seconded and it was unanimously agreed that the application be rejected as it was outside development boundary and Hempnall parish council opposes any development of the village outside the currently defined development boundary. We support infill of small groups of dwellings and small-scale businesses and services inside the development area demarcated by this boundary but oppose large scale housing estates. In addition, the design is inappropriate to the location and not sympathetic to nor in keeping with the local character of the area.
