District Councillor Update

Planning Applications

New applications since the last meeting:

2022/1297 - Mr Simon Carver, Pear Tree Farm Alburgh Road Hemphall - Demolition of existing outbuilding and erection of carport and garage with office space and gym above.

Mr Carver explained the rationale behind the application, showed some artists impressions and answered councillors' questions.

Mr Delf proposed, Mrs Allen seconded, and it was unanimously agreed subject to one abstention that the application be approved.

2022/1745 - Mr & Mrs Tim & Gill Vowles, Croeso, Fairstead Lane Hempnall - Remove existing roof and raise roof to create a dormer bungalow. Remove existing rear 'lean-to' extension and replace with a single-rear storey extension. External wall insulation with render finish. Open-sided porch over front door. Solar Photovoltaic panels to South facing roof elevation. – Mr Turner proposed, Mrs Allen seconded, and it was unanimously agreed that the application be approved.

2022/1803 - Mr Sean Charlton, Spring Farm Spring Lane Hempnall - Erection of glasshouses, polytunnels, general purpose agricultural storage/cold store building, biomass building, water storage tanks, thermal water tanks, drainage and landscaping.

There was much discussion about this application. The residents and councillors in attendance were absolutely opposed to the plans and this led to a proposal by Mr Workman, which Mrs Cann seconded, that the application be refused. This recommendation for refusal was unanimously approved by councillors who also agreed that a full and detailed letter of objection would be sent to SNC by the deadline of 17 October 2022.

The grounds for objection were identified as:

- A lack of an NCC highways assessment and numerous concerns about increased traffic flows and their impacts
- Visual impacts in an area of rural, attractive and tranquil landscape
- Increased light pollution in an area of rural dark landscape
- Loss of a Greenfield
- Transformation of a Greenfield into an industrial style operation including a large packaging building
- The impacts on drainage (including unknown impacts of foul sewage) in an area that suffers greatly in this regard due to the high water table
- Potential impacts on the number of residential caravans on site at a location outside
 the settlement limit (development boundary) in Hempnall the applicant requested
 48 extra caravans which, although not part of this application at present, represent
 a large future threat
- The fact that the site is not identified as an employment site in the current local plan (The Joint Core Strategy)
- Impact on visual amenity for the users of local PROW including footpath 24 which runs through the site
- Impact on water supply in an area that suffers from low water pressure through industrial scale irrigation
- The magnitude of the development potentially trebling the size of the operation
- Loss of good arable land
- Increased noise in a tranquil area helicopter flights in to site, night time parties at weekends, fork lift movements and other industrial disturbances created by the operation
- No Environmental Impact Statement
- A failure to engage with the local community e,g by attending a parish council meeting
- Too close to existing dwellings impacts on neighbours
- Does it comply with Defra guidance on polytunnels and glasshouses?
- It is questionable to call this an agricultural operation it would look like an industrial enterprise
- Destruction of habitats for flora and fauna and negative implications for the movement of the local red deer population
- The local community was not invited to contribute to pre application discussions between the developer and SNC which have taken place since February 2022
- Concerns about a past history of retrospective applications re. this operation

The Clerk had passed on Mr Holland's comments to the Highways Authority (NCC) who responded as follows: "Unfortunately this is not something we would consider, the existing speed limit applies to both 4 wheel and two-wheel traffic, the signs on Newmarket Road are for the cycle lane". The Clerk had informed Mr Holland.

Anti-social behaviour at night on playing field

Since the Clerk had spoken to young people on the play area, troubles had ceased for a while, but there was glass found again last weekend, hopefully a one off.

Speed Watch Team

The Clerk had written to Mr Elliot and provided councillors with his response and included Mr Elliot's article in the parish council's newsletter.

Cost of Bus Shelter repair

The Clerk and Mr Delf had settled this matter with James Banner by paying the contracted amount quoted and the additional costs for extra work. Total paid £827.33 not the £1096.00 invoiced.

Footpath and bridleway / Crossfield cutting

The Clerk had written to Mr David Penn requesting that when he replants the field, he ensures the footpath is clearly accessible.

Alburgh Rd repairs

The poor road condition of the road surface at Alburgh Rd / B1527 junction and Villa farm entrance, had not been attended to by NCC, but they updated on 11/08/22 that the road is on the schedule for resurfacing, prior to which any additional minor or new defects will be repaired. The Clerk to monitor.

Tree Preservation orders for Playing Field

SNC had issued consultation re TPOs on an additional 7 trees around the playingfield and the Clerk had responded and awaits SNC decision.

Planning permissions & Business Rates

Andy Baines, SNC enforcement officer reported as follows:

"I have contacted business rates who have all but one of the businesses listed. That being Harvey Lane Garage. They will carry out their own investigation into this and do what is necessary. I have invited an application for the garage use to be regularised.

I have also requested an application for the Evergreen Insulation business."

Caravan encampment at Spring Wood

Andy Baines, SNC enforcement officer reported as follows:

"I visited the site, and it appears the use of this area is well established and could possibly be immune from enforcement through the passage of time. I am currently looking into the use and structures to establish how long they have been there."

Mr Baines had indicated that, in short, buildings become immune from action after 4 years and use of land becomes immune from action after 10 years.

Hempnall Natural Flood Management scoping report

We await the outcome of liaison of the National Flood Manager for East Anglia with landowners. The Clerk to monitor.

Speed limit on Alburgh Road

The Clerk to inform the parishioner, Mrs Judy Askew, who raised the matter and invite her to the November meeting to discuss speed issues in general.

Churchvard Tree Pruning – Holme Oak

Mark Havens to prune the Holme Oak in October/November. The Clerk had also applied for and received planning permission to undertake the work. The Clerk to monitor.

IN

Extra 20mph sign in The Street

The Clerk had written to NCC Highways to ask for another 20mph sign to be erected on the other side of the road to the one above as the one on the left, even when not obscured by the hedge, was not prominent enough to alert drivers. Gary Overland said, "Although I have not had an opportunity to inspect, I do not foresee why this would not be possible, but as it will require a new sign, we would have to look to Alison to fund the work". The Clerk to monitor.

Bollard on B1527

The Clerk had chased NCC re the erection of a bollard on the pavement and Gary Overland of NCC Highways had responded as follows: "A bollard would prevent vehicles cutting across the new tactile paving when entering and exiting the new development but have not had a chance to run this past Julian Fonseka for approval. "The Clerk to Monitor.

Roadside nature reserves

Mr Driver has received a response from NCC Ecologist, Sonia Seaton who will take action with Mr Driver in the Spring.

Roberts Close / The Street footpath safety

The Clerk had written to highways on 5 January 2021 outlining the safety issues and possible solutions. NCC responded to say they "do not have a problem dropping the kerbs on the opposite side of the road to create a crossing point. The kerbs are not at full height anyway, but they would obviously be better with a standard 25mm upstand. We would not consider installing waiting restrictions at this location, but I think that some h-bar markings (11m length) would help deter drivers from parking close to the bend. This reply obviously crosses over two no enquiries at the same location" The Clerk to monitor.

This can't be considered until after the result of the safety audit being carried out funded by County Councillor Thomas.

Millfields Exception Site

We await Richard Bland of Saffron Housing / SNC since July 2022 and details of the law re tenants right to purchase to ensure that the properties were retained in perpetuity as social housing. The Clerk to monitor.

Dog Bin - footpath 9 off B1527

Mr Delf had erected the bin and replaced the footpath sign at the same time.

Jubilee Trees for Norfolk

This matter is carried forward as no land was available at present. Mr Hook explained that public access was not necessary, however it was a requirement that the public would see the trees. Councillors to inform Mr Hook of any sites asap. The Clerk to ask the secretary of the Church & Town Estate Property Charity to agenda tree planting on its land.

Mr Delf reported that he had tried to start the roller, but the engine was seized and could cost a lot to repair. He had also made enquiries about the market value of the roller and had been informed that it is not a piece of equipment that any current contractor would buy. It is estimated that it may fetch c£450 in scrap value. Mr Hook proposed, Mr Driver seconded, and it was unanimously agreed that Mr Delf should arrange for the sale of the roller for scrap and that the money be used to help pay for the demolition of the garage. A quote to be obtained for this by the sub-committee.

The Clerk had checked who were the official parish council representative, they are Mark Williams (due for re-election Oct 2024) and Chris Barnes (due for re-election Feb 2024), thus another is required.

Mr Rose to investigate further although the government had withdrawn the 2025 deadline for historic footpath registration.

It was agreed that the Clerk should ask NCC PROW if it were possible to have a supply of 6 figure posts for the parish council to erect to replace existing broken / missing ones.

Invitation to Bid for Parish Partnership 2023/24

Bids need to be submitted by 09 December 2022. Mr Edney Had supplied the Clerk with information about the Community Action Fund.

The Clerk had obtained a quote from Mark Havens (preferred contractor of NCC) to widen the concrete footbridge on footpath 9 by adding metal plates either side and moving the handrails. The Clerk had established that planning permission would not be required for bridge widening and NCC PROW were happy to support this project. The Clerk is still investigating the ownership of the land on which the bridge stands, thought to be the Internal Drainage Board, so as to seek their permission.

The Clerk had received NCC's agreement to fill in the ditch which crosses footpath 12. A pipe will be put in to take the water and the ditch filled. This should be funded in full by NCC.

The bridge leading from footpath 12 to footpath 18 (Lower Lane to Hardy's Loke) needs widening with a couple of extra planks. NCC PROW were happy to support this project and a quote had been obtained from Mark Havens.

Mr Driver proposed, Mr Hook seconded, and it was unanimously agreed that the Clerk should prepare a submission for the Parish Partnership scheme for both bridge widening projects and seek County Councillor Thomas' support.

Due to difficulties of moving the school's defibrillator and the fact it was for use on children only Mr Hook proposed, Mr Driver seconded, and it was unanimously agreed that a dual use defibrillator be installed in the phone box instead (which already had an electric supply).
