## Minutes of the Parish Council meeting held on Tuesday 16 April 2024 at 7:00pm in the Mill Centre

### Present

### Apologies

Apologies were received from District Councillor Martyn Hooton.

### Declaration of interests

Mr Hook declared an interest in the CPRE matter.

### Minutes of the previous meeting

Mr Elliott proposed, Mr Bates seconded, and it was unanimously agreed the minutes of the meeting on 19 March 2024 be approved.

### Public Participation

Mr Rogers wished to continue to bring the speeding traffic issues on Alburgh Rd to councillors' attention, which was considered further under the B1527 declassification matter.

### County Councillor Update

County Councillor Alison Thomas provided the following report.

The Long Stratton bypass work will start Monday next week, with the appropriate road closures. This will impact on traffic volumes in surrounding villages over the build period of 18 months.

### District Councillor Update

District Councillor Mr Martyn Hooton had reported prior to the meeting that there were no new parish issues.

## **B1527 Declassification / road safety in general**

Mrs Thomas had reported that the cost of the route classification review far exceeded the budget available to both her and the other county councillor in our area. She went on to report that a potential route reclassification would require extensive public consultation over a wide geographical area, and with legal costs and construction costs factored in, we would be looking at a very substantial amount of money, which is not something NCC have for this type of project at this time.

Mr Delf proposed, Mr Elliott seconded, and it was unanimously agreed that the Clerk should respond to express the parish council's disappointment and ask what measures are now open to NCC Highways and the parish council to protect its residents from speeding and large vehicles. The Clerk and Mr Hook to present a summary of all outstanding safety measures communicated to NCC and in addition ask for the legal basis on which NCC state that unless the B1527 is declassified and re-defined as no longer being a lorry route it is not possible to introduce traffic calming measures such as chicanes. The request for a meeting with Gary Overland is to be repeated so that practical solutions can be found for all areas of the village. The fact that the parish council is prepared to help fund and organise road safety measures is also to be re-presented to NCC Highways.

## **Roadside nature reserves / rewilding verges**

The Clerk had received the following report from the NCC Ecologist, Sonia Seaton "*I have put forward one verge near Silver Green as an RNR. I have provisionally allocated this verge as RNR140. I have attached a map of the location. The new Roadside Nature Reserves that have been recommended are being reviewed by our Highways Engineers. However, this verge needs appropriate management as it was a borderline verge for RNR status. For example, it would be important for adjacent land owners or other individuals not cut this verge, this spring. I understand from my 3 site visits to this location, that this verge is cut more than once a year! Therefore, improved management is essential for this habitat to flourish. When funds become available, RNR posts will be erected, but this may not be carried out before the verge cutting season in May. The Green Spaces Team have planned to send letters to adjacent landowners, to make them aware of the importance of these verge locations, when the RNRs have been approved by Highways.*".

Mrs Cann proposed, Mr Delf seconded, and it was unanimously agreed that the Clerk write to Sonia to thank her for progress and inform her that the parish council supports the above. The Clerk to monitor progress.

## **Streetlight timers and heads**

Mr Hook had obtained a quote from Amey, to replace the 6 streetlight heads in Roland Drive with LEDs lamps incorporating timers which would not need to be reset after every power cut. The new lights would be LEDs and have better controls to facilitate accurate timing. The new lights would be more environmentally friendly and there would be savings in power usage and maintenance requirements. It would also help ensure a better service for parishioners. The new lights would be full cut-off, 4000 Kelvin (neutral white) and cost £4604.54 plus VAT fitted. Mr Delf proposed, Mr Bates seconded, and it was unanimously agreed to upgrade the lights and contact UK Power Network for a reduction in electricity cost for the unmetered connection.

## **National Grid - NISP – Consultation**

Mr Hook proposed, Mr Elliott seconded, and it was unanimously agreed that Mr Hook and the Clerk should restate the parish council's previous response in the current consultation by the deadline of 18/06/2024 with emphasis being placed on routing the cables via the seabed or underground.
